MONDAY, June 2, 2025
MEETING MINUTES

The Huron Township Board of Trustees met on Monday, June 2, 2025, at 6:00 PM., in the Township Office, 1820 Bogart Road, Huron, Ohio. Present were Chairman Edward Wimmer, Trustee Gordon Hahn, Trustee Ray Enderle, Building Official John Zimmerman, and Fiscal Officer Matt Dewey.

Chairman Wimmer called the meeting to order and led all in attendance in the "Pledge of Allegiance".

MINUTES

A motion was made by Mr. Hahn, with a second from Mr. Enderle, to approve the May 5, 2025, minutes as printed. The motion passed unanimously.

FINANCIAL

A motion was made by Mr. Hahn, seconded by Mr. Enderle, to approve the financial report and the payment of bills. The motion passed unanimously.

FINANCIAL STATEMENT

The Trustees were presented the following financial information for Huron Township for the month ending May 31, 2025:

Check#16267 (\$394,507.75) to City of Huron (2nd Q Fire & Joint Rec) was dated 6/3/25 but was cashed on 5/30/25. This amount is the difference of 5/31/25 EB and 6/1/25 BB. This is noted on the 5/31/25 Bank Reconciliation.

PUBLIC PARTICIPATION

There were no public comments

ZONING

Mr. Zimmerman reported that 26 permits were issued during the last reporting period. He said there are numerous large projects coming up this year.

He continued that the proposed Scott Cemetery Agreement, between the City of Huron and Huron Township, was tentatively approved by the Prosecutor. We are now waiting for the City to take their necessary action.

He then requested that Robert Stadler, our Backup Building Official and Backup Building Inspector, receive a salary increase from the current \$400 (bi-weekly) to \$600 (bi-weekly). Mr. Zimmerman explained that Mr. Stadler's workload is increasing as is the activity of the Building Department. **Mr. Hahn made the requested motion with a second by Mr. Enderle. The motion passed unanimously.**

Last, Mr. Zimmerman brought the Trustees up-to-date on the possible apartment complex planned for the area north of Rt. #2 and Mudbrook Road in front of Thunderbird Hills North Course. He said it is still in the planning stage. Mr. Hahn added that the developer is working with Greater Sandusky Partnership and the Huron Port Authority to secure infrastructure funding.

ROAD REPORT

The Road Report was accepted and reviewed as submitted by Road Superintendent Eric Boger.

GENERAL

Mr. Zimmerman emailed the monthly Sheriff's Report to the Trustees.

ROUND TABLE

Mr. Enderle brought up the Galloway Road stump and both Mr. Wimmer and Mr. Hahn said they looked at it and felt it is an "eyesore". Mr. Wimmer said he talked with Buckeye Tree Service and the \$800 cost of removing the stump is still valid. **Mr. Enderle made a motion to accept the \$800 quote from Buckeye Tree Service to remove the stump with a second by Mr. Hahn. The motion passed unanimously.** Mr. Zimmerman reminded the Trustees that the Road Department is too busy to assist Buckeye and all agreed.

Mr. Hahn said the Summer Employee (Paul Maloney) started this morning.

Mr. Wimmer said he saw that the invoice for the Memorial Day flags exceeded what was approved by \$250. **Mr. Enderle made a motion to approve the purchase of said flags in the amount of \$1,750, with a second by Mr. Hahn. The motion passed unanimously.**

Mr. Enderle made a motion to cancel the June 16, 2025, meeting. With a second by Mr. Hahn, the motion passed unanimously. The next regular meeting is Monday, July 7, 2025, at 6:00 PM.

With no further business for the Trustees, **Mr. Enderle made a motion to adjourn at 6:45 PM, with a second by Mr. Hahn.**
