MEETING MINUTES

The Huron Township Board of Trustees met on Monday, July 7, 2025, at 6:00 PM., in the Township Office, 1820 Bogart Road, Huron, Ohio. Present were Chairman Edward Wimmer, Trustee Gordon Hahn, Trustee Ray Enderle, Building Official John Zimmerman, and Fiscal Officer Matt Dewey.

Chairman Wimmer called the meeting to order and led all in attendance in the "Pledge of Allegiance".

MINUTES

A motion was made by Mr. Enderle, with a second from Mr. Hahn, to approve the June 2, 2025, minutes as printed. The motion passed unanimously.

FINANCIAL

A motion was made by Mr. Hahn, seconded by Mr. Enderle, to approve the financial report and the payment of bills. The motion passed unanimously.

FINANCIAL STATEMENT

The Trustees were presented the following financial information for Huron Township for the month ending July 31, 2025:

PUBLIC PARTICIPATION

Rick Scheel, Galloway Road, asked the status of the Willow Creek Drainage project. Mr. Zimmerman said it was in the process of final consideration of the Erie County Commissioners. James Hall, East Perkins Ave., had comments about the upcoming Cleveland Road project. Mr. Zimmerman reminded him this is a State of Ohio project and his questions, comments, and concerns should be directed to ODOT.

ZONING

Mr. Zimmerman reported that 36 permits were issued during the last reporting period. He said there are numerous large projects coming up this year.

RESOLUTION 2025-09

A RESOLUTION OF THE HURON TOWNSHIP TRUSTEES CONSENTING TO THE MANAGEMENT AND ADMINISTRATIVE AGREEMENT FOR SCOTT CEMETERY.

Mr. Zimmerman explained that this action, along with action taken previously by the City of Huron, will transfer all responsibility and authority for Scott Cemetery to Huron Township. At their meeting on July 9, 2025, the Scott Cemetery Board of Trustees will disband the Board and transfer all monies from the Cemetery account to Huron Township for deposit in their Cemetery Fund. **Mr. Enderle made a motion to approve Resolution 2025-09 with a second from Mr. Hahn. The motion passed unanimously.**

ROAD REPORT

The Road Report was accepted and reviewed as submitted by Road Superintendent Eric Boger.

GENERAL

Mr. Zimmerman emailed the monthly Sheriff's Report to the Trustees.

Mr. Zimmerman presented the Trustees with quotes to renovate the retention pond and clean up our landscaping around the building. After review of the submittals, **Mr. Enderle made a motion to award the bid for the pond work to Michael Bledsoe, 2913 Huron-Avery, in the amount of \$6,500. Mr. Hahn seconded the motion and it passed unanimously. Next, Mr. Hahn made a motion to award**

**the landscaping work to A1 Services, Huron, in the amount of \$3,250. Mr. Enderle seconded the motion and it passed unanimously.**

Mr. Zimmerman told the Trustees that the emergency tree work was completed at McMillen Cemetery in the amount of \$5,800.

He continued that the buoys for the "No Wake" area on the Huron River would not be available, at no cost, until next April. He said he would continue to work with ODNR to get the area officially designated and request the buoys at the appropriate time.

**ROUND TABLE**

Mr. Enderle said he has invited a Boy Scout to our next meeting. He said the person is working for his Eagle Scout Badge and Mr. Enderle thought the exposure to our meeting would be a help

Mr. Hahn said the Road Crew is doing a good job on the roads and roadsides.


Mr. Dewey presented the Trustees with the 2026 Tax Budget and said the Public Hearing will be at the next meeting.
