**MEETING MINUTES** 

The Huron Township Board of Trustees met on Monday, September 8, 2025, at 6:00 PM., in the Township Office, 1820 Bogart Road, Huron, Ohio. Present were Chairman Edward Wimmer, Trustee Gordon Hahn, Trustee Ray Enderle, Building Official John Zimmerman, Fiscal Officer Matt Dewey, and Road Superintendent Eric Boger.

Chairman Wimmer called the meeting to order and led all in attendance in the "Pledge of Allegiance".

# **MINUTES**

A motion was made by Mr. Enderle, with a second by Mr. Hahn, to approve the August 4, 2025, minutes as printed. The motion passed unanimously.

## **FINANCIAL**

A motion was made by Mr. Enderle, seconded by Mr. Hahn, to approve the financial report and the payment of bills. The motion passed unanimously.

## FINANCIAL STATEMENT

The Trustees were presented the following financial information for Huron Township For the month ending September 30,2025:

## **FINANCIAL**

A motion was made by Mr. Hahn, seconded by Mr. Enderle to approve the financial report and the payment of bills. The motion passed unanimously.

### **PUBLIC PARTICIPATION**

There were no public comments.

#### ZONING

Mr. Zimmerman reported that 40 permits were issued during the last reporting period.

He also informed the Trustees that, after discussing the existing Cleveland Road signs with the County Prosecutor, it has been decided that the signs that will not be removed by ODOT, as a result of the larger right-of-way along the Cleveland Road project, will be permitted to remain in-place provided they are not considered a traffic hazard.

# **ROAD REPORT**

The Road Report was accepted and reviewed as submitted by Road Superintendent Eric Boger.

## **GENERAL**

Mr. Zimmerman emailed the monthly Sheriff's Report to the Trustees.

Mr. Wimmer informed the Trustees that Road Department Employee Brett Thayer will complete his probationary period on September 30<sup>th</sup>. He requested that Brett receive a \$1.00 per hour salary increase and 24 hours of vacation time (to be used by 12/31/25). **Mr. Enderle made the required motion with a second from Mr. Hahn. The motion passed unanimously**.

Mr. Wimmer told the Trustees that the final step in the Complex "beautification" project is stamped concrete along the front walk and a 16' x 16' stamped area where the flagpole and the landscaping were removed. He said Custom Concrete, Huron, submitted a quote of \$9,360 for the entire area. **Mr. Hahn made a motion to approve the quote with a second by Mr. Enderle. The motion passed unanimously**.

Mr. Wimmer asked Mr. Zimmerman to explain the "forgiveness" of a portion of the Cemetery Tax. Mr. Zimmerman explained that the Township collects .3 Mills of taxation for the Township Cemeteries. Annually, the tax collects approximately \$90,000, for the cemeteries and the Trustees have the authority to forgive a portion of that tax on an annual basis. After a discussion, Mr. Hahn said he felt comfortable forgiving .2 mills of the .3 mill tax for the upcoming tax year. He said the .2 mills would actually "forgive" approximately \$60,000 for 2026.

## **RESOLUTION # 2025-11**

RESOLUTION OF THE BOARD OF TRUSTEES OF HURON TOWNSHIP, ERIE COUNTY, OHIO, TO REQUEST THAT THE ERIE COUNTY AUDITOR NOT COLLECT .2 MILLS OF THE .3 MILL CEMETERY TAX LEVY DESIGNATED FOR THE TOWNSHIP CEMETERY FUND FOR THE TAX YEAR 2025 TO BE COLLECTED IN 2026.

Mr. Hahn made a motion to approve Resolution 2025-11 with a second by Mr. Enderle. The motion passed unanimously.

Road Superintendent Boger discussed possibly paving Scott Cemetery. He said he received two (2) quotes. After a lengthy discussion, the matter was tabled until more information could be presented.

Road Superintendent Boger then brought up possibly installing new signs identifying the Township owned and maintained Cemeteries. After a brief discussion, the Trustees asked Mr. Boger to get more information and submit it at a later meeting.

# **ROUND TABLE**

Mr. Enderle said he had nothing to report.

Mr. Hahn said the Road Department had requested trimming trees in the Fitgerald Subdivision. Superintendent Boger said snowplows and other equipment have hit low limbs and he felt the trees should be trimmed. He said he would get a quote to trim the trees in the subdivision.

Mr. Hahn reminded the Trustees that the Erie County Township Trustees quarterly meeting will be held at our Complex on Thursday, September 11<sup>th</sup> at 7:00 PM.

Mr. Wimmer said he had nothing to report tonight.

Mr. Hahn made a motion to cancel the September 15, 2025, meetings. With a second by Mr. Enderle, the motion passed unanimously. The next regular meeting is Monday, October 6, 2025, at 6:00 PM.

With no further business for the Trustees, Mr. Enderle made a motion to adjourn at 6:59 PM, with a second by Mr. Hahn.
